



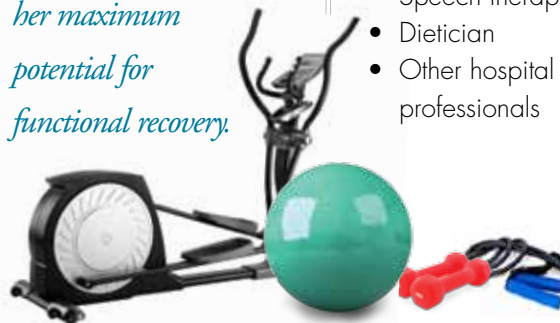

Located on the sixth floor of the hospital, the IRU is licensed to provide nursing and intense therapy in an acute care setting.

THE REFERRAL PROCESS

Physician may request a referral from any healthcare setting, such as emergency room, physician office or home. Patients can be admitted from our acute care unit or transferred from another acute care setting.

A pre-admission screen must be completed to determine if you meet the criteria for Acute Rehab:

- Medical stability
- Ability to participate in intense rehab for 3 hours per day for at least 5 days per week.

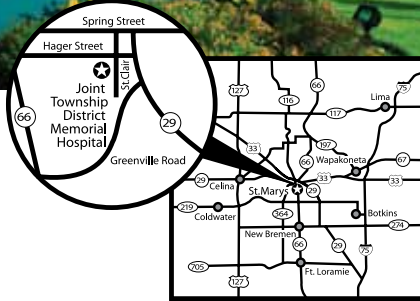

A FULL RANGE OF CARE

Typical injury or illness appropriate for the Inpatient Rehab Facility includes:

- Stroke/CVA
- Brain dysfunctions such as brain trauma/injury or brain surgeries
- Neurological disorders such as Multiple Sclerosis, paralysis or Parkinson's
- Spinal cord injury of trauma
- Orthopedic conditions such as joint replacement, scoliosis, hip dysplasia, failed hip replacements
- Amputations
- Hip Fractures
- Multiple joint arthritis such as rheumatoid arthritis
- Major Multiple Trauma
- Generalized Weakness and debilitation resulting from complex medical conditions
- An on going condition that complicates your recovery or returning to prior level of function
