The Auglaize County Vaccine Providers continue to administer vaccines for those eligible. With the emergence of the Delta Variant of the COVID-19 virus, it puts those that are not vaccinated at even greater risk.

The following groups currently qualify for the COVID-19 vaccine.

- 12 years of age and older
  - With parental or legal guardian consent, individuals age 12 to 17 are eligible to receive the Pfizer vaccine, which is the only COVID-19 vaccine currently authorized for those under the age of 18. The Moderna and Johnson & Johnson/Janssen vaccine is only authorized for those that are 18 years of age and older.

An additional dose of the COVID-19 vaccine (Pfizer and Moderna only) has been approved for the following group:

- Individuals with moderate to severe immunosuppression who are at heightened risk for serious outcomes from COVID-19, including
  - Individuals undergoing active treatment for cancer.
  - Individuals who have received a solid-organ transplant and are taking immunosuppressive therapy.
  - Individuals who have received a CAR-T-cell or hematopoietic stem cell transplant (within two years of transplant or taking immunosuppression therapy).
  - Individuals with moderate or severe primary immunodeficiency.
  - Individuals with advanced or untreated HIV infection.
  - o Individuals undergoing active treatment with high-dose corticosteroids (i.e., ≥20mg prednisone or equivalent per day), alkylating agents, antimetabolites, transplant-related immunosuppressive drugs, cancer chemotherapeutic agents classified as severely immunosuppressive, tumor-necrosis (TNF) blockers, and other biologic agents that are immunosuppressive or immunomodulatory.
- Those qualifying for an additional dose are strongly recommended to speak with their doctor to determine next steps. A patient's doctor is best positioned to determine the need for an additional vaccine dose.
